# a. Consultant Report

## b. Bathroom Update:

The new design was presented to the Board. Once the design is finalized then it can go out for bid. Rob Larrea stated the initial intent was to begin construction this year.

Manager's Update: Rob Larrea noted that the Village Council will be discussing raising water rates at their next meeting. This is to help offset state mandated infrastructure improvements. He added that the Village Council determined at their last meeting that EV charging stations are not a top priority.

Information and comments:

Board Members Comments: Sitkens noted that Inland Seas is currently investigating EV charging stations. Dan Derigiotis stated that Hansens has also looked into them to be placed on site. Bahle and Young noted they supported the idea of EV stations in the Village. It was suggested to review the DDA plan before considering this as an agenda item.

Public Comments: Bill Crackel suggested all improvements accomplished by the DDA should have a sign attached noting this contribution. He added he appreciated the incremental water rate increase proposal rather than a large increase.
