PURPOSE

To consider a contract proposal to replace the archaic Marina Beach electrical panel.

OVERVIEW

For several years, an electrical panel at Marina Park provided electricity for various events, such as the Art Festival, Jazz Festival, and on a smaller scale, a pump at Marina Park. As with all infrastructure, modern technology advancements and age has all but made the panel obsolete. After prolonging its removal/upgrade for a couple years, it is now need of our attention.

This panel is archaic and has met its lifecycle but more importantly, it is quickly becoming a hazard. The cost to install a new outdoor panel in a similar location, which is not suggested, would cost more than if we were to relocate the panel in its entirety. Being that the village hall is only a few years old, if we were to use our current village hall infrastructure, the cost to replace the panel with a modern panel would be much less. We would still need to address the issues at the current panel, however, the cost to rebuild at that location does not make sense now that the hall already offers many of the needed upgrades.

Calls to various electrical companies varied in cost however the most difficult variable was timing. Upon recommendation, we did contact a company that could meet our timeline and provided a reasonable and acceptable quote for the service at approximately \$7,700. A breakdown of the quote includes approximately \$4,100 for addressing the old panel and approximately \$3,607 for the new panel.

REQUESTED ACTION

Should the village council feel it is appropriate to move forward with the request in its entirety, a motion for consideration is as follows:

MOTION TO allow an amount not to exceed \$7,700 towards removing and replacing the Marina Park electrical panel as described in Report VSB-2023-29.

ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT PROVISIONS OF THE STATE CONSTRUCTION CODE

Community Name: Village of Suttons Bay, County: Leelanau

An Ordinance to Repeal Village of Suttons Bay Ordinance No. 4 of 2018 and to designate an enforcing agency to discharge the responsibility of the Village of Suttons Bay located in Leelanau County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

The Village of Suttons Bay ordains:

Section 1. AGENCY DESIGNATED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Construction Code Office of the County of Leelanau is hereby designated as the enforcing agency to discharge the responsibility of the Village of Suttons Bay under Act 230, of the Public Acts of 1972, as amended, State of Michigan. The County of Leelanau assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of the community adopting this ordinance.

Section 2. CODE APPENDIX ENFORCED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the jurisdiction of the community adopting this ordinance.

Section 3. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS. The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "The Flood Insurance Study for Leelanau County, All Jurisdictions", effective June 7, 2023 and the Flood Insurance Rate Map (FIRM) panels contained on index panel 26089CIND0B, effective June 7, 2023 are adopted by reference for the purposes of administration of the Michigan www.michigan.gov/deq 1 EQP9242 (2/2017)

Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

Section 4. REPEALS. All ordinances inconsistent with the provisions of this ordinance are hereby repealed. *Village of Suttons Bay Ordinance No. 4 of 2018 is hereby Repealed.*

Section 5. PUBLICATION. This ordinance shall be effective after legal publication and in accordance with the provisions of the Act governing same.

I commend you for the efforts that have been put forth in implementing the floodplain management measures for the Village of Suttons Bay, Michigan, to participate in the National Flood Insurance Program (NFIP). As you implement these measures, I want to emphasize the following:

- a Flood Insurance Study (FIS) and Flood Insurance Rate Map (FIRM) have been completed for your community;
- the FIS and FIRM will become effective on June 7, 2023; and
- by the FIS and FIRM effective date, the Department of Homeland Security's Federal Emergency Management Agency (FEMA) Regional Office is required to approve the legally enforceable floodplain management measures your community adopts in accordance with Title 44 Code of Federal Regulations (CFR) Section 60.3 (e).

As noted in FEMA's letter dated December 7, 2022, no significant changes have been made to the flood hazard data on the Preliminary and/or revised Preliminary copies of the FIRM for Leelanau County. Therefore, the Village of Suttons Bay should use the Preliminary and/or revised Preliminary copies of the FIRM as the basis for adopting the required floodplain management measures. However, in the event your community has not adopted the appropriate measures, this letter is FEMA's official notification that you only have until June 7, 2023, to adopt and/or submit a floodplain management ordinance that meets or exceeds the minimum NFIP requirements, and request approval from the FEMA Regional Office by the effective date. A three-year contract extension was entered into with the Sheriff Department beginning in 2023, and following a series of 1-year extensions. Our contract, specifically requires officer Donahue to work five 8-hour shifts, which is a departure from the four 10-hour shifts other Leelanau officers typically work.

Over the winter months, I agreed to allow officer Donahue (on a trial basis) the ability to work four 10hour shifts. This decision was rather easy considering the relatively steep drop in tourism during the winter months. He is now requesting that the village consider extending his ability to work the four 10hour shifts through the summer months.

Although this is ultimately a Staff decision, I am requesting that the Village Council weigh in on this requested change.

RECOMMENDATION

Discussion and a consensus.
